South Wyaconda Baptist Church, Union Twp., Clark County, MO

The Antioch Baptist Church was first organized November 15, 1873, by Rev. N. Nelson, with 36 members. Some of the charter members were, Mr. & Mrs J.P. Samson, Mr & Mrs William Mitts, Mrs S.R. East, Mrs Harriet McAfee, Dr. & Mrs Skirvin, Mrs Martha Clay, Hanslow Fields and Mr & Mrs Sam P. Clay.

George Kell, who was a minister and moderator of the Wyaconda Association from 1904 to 1915 and Mrs. Martha Fields and Sam P. Clay were relatives. George Kell's grandparents were some of the early settlers who came to the Antioch area in 1834 and settled 1½ mile south of Antioch, which at that time was covered with prairie grass.

Services were first held half mile south of Antioch in the school house. Then the Baptist Church at Winchester was disbanded and the material from the church was moved to Antioch and the First Antioch Baptist Church was built.

In 1920 a new church was built of stucco on the same site and the first services were held there on January 1, 1921. Because of some storm damage, the building was covered with weather boards and extensive work was done on the inside.

The ministers who went out from the Antioch Church were- Rev. Ernest Chewing, Rev. James P. Samson, Rev. Walter Fleming, Rev Ed Fleming, Rev. Freddie Kirchner, and Rev. Russell Kirchner, all since deceased.

On Sept. 6, 1959, a meeting was held for the purpose of disbanding the church, and those in regular attendance uniting with the Kahoka Baptist Church and others. Rev. Harry Wigger, district missionary, acted as moderator. A motion was made, seconded and carried that we deed all deedable property to the Kahoka Baptist Church. It was agreed that the church must be torn down and not used for any other purpose. A motion was also made and seconded that Clerk, Ruby Kirchner, grant letters to those wishing to unite with other Baptist churches.

**SOUTH WYACONDA BAPTIST CHURCH CELEBRATED EIGHTIETH ANNIVERSARY
SUNDAY, OCT. 30, 1927**

The South Wyaconda Baptist church was organized by Rev. James M. Lillard Jan. 16, 1847 with the following charter members: Hesakiah Foree, Francis Foree Sr., Francis Foree Jr., William Lillard, Mary Clay, Ephrama Smith, James M. Foree, Isabell Maddox, Charles Maddox, Malinda Black, Martha Black, Joseph Wells, Sr., Elizabeth Wells and Sophia Foree.

A presbytery consisting of J. M. Lillard from Dover church, Brethren E. Lipper, W. Tuley and G. Pulliam from Wyaconda church, and B. Mosley from Fox river church, M. Basket and M. Wood from Bear Creek church.

By a unanimous vote of the church it was declared the name should be South Wyaconda Baptist church. About this time the church and neighborhood built a school house. It was built out of rough logs, and pointed with mud. It was covered with clapboards, and had a stick chimney and a puncheon floor. The church met in this building for a number of years. About 1850 a man by the name of Kibby taught the school and during this year the house burned down, after which the church built a very nice house for that time, located near Barton Kontz's present home. This house was burned in 1864. Brother Charles Maddox was the first pastor. He died about the year 1850. Then the church called Rev. Jephtha Smith who served the church for several years, after which Rev. James Moncrief was chosen as pastor and served until the rebellion in 1861.

During this stormy period Rev. Jas. Lillard held a number of revival meetings which resulted in a good many additions to the church.

The ministers during this time were paid in yarn socks, jeans pants, vegetables and anything the members could spare and the preacher needed. During the war the church held no services.

*In 1867 the church met at Joseph Wells, and after preaching by Rev. Charles Ingman he was chosen moderator, and by a unanimous vote of the members was elected pastor for one year. On motion and second that a new list of members be made and all those in good standing be transferred from the old book to the new one, the following brethren and sisters answered to the roll call: Heseiah Foree, Sr., Joseph Wells, Elizabeth Wells, Edward Bruner, Mercy Bruner, J. M. Foree Jr. (by letter), Mary Foree, Virginia Lillard, William Lillard, Walker Lillard and Malinda Black. Rev. J. M. Lillard and Rev. N. Nelson held a revival meeting in December which resulted in twenty-one additions to the church. Bro. Ingman having moved away, the church called Brother N. Nelson as pastor for one year. In July 1869 the church called Bro. Robert Wayland for the ensuing year. In 1870 the church called Bro. James Golden who served for some five years. Then the church called to its pastorate Bro. J. F. Suter. In 1877 the church called again Bro. James Golden who served as pastor until 1880 when he died at Bro. L. B. Hume's. After his death the church called Bro. N. Nelson again who served for some three years, when the church called William Pulliam for the ensuing year. Bro. R. L. Wayland served in 1885 N. Nelson in 1886, John Golden in 1887, O. F. D. Wilson in 1888, Wm. Baird in 1889, and George Beard 1889 to Aug. 1897. C. W. Nicols from Aug. 1897 to Oct. 1897, W. F. Wyatt was then elected and served to April 1898. In May of that year Bro. J. R. Penington was called and served until 1903. Bro. W. M. Cooney served until 1906, when Bro. L.P. Smith was called and served until 1910, **after which Bro. Ernest Chewning served to 1912**, then Bro. J. H. Spindler served until 1914, after which Bro. Kell was called and served for two years. Bro. C. E Newton served from 1916 to 1923. Rev. C. E. Hutchinson then served for about a year when Bro. Bartine was called and is still in our pastorate.*

The South Wyaconda Baptist church met in the home of Bro. Joseph Wells continuously, from 1867 until 1871 when they moved to the new school house where they worshiped until they built a commodious house for themselves in 1879 and 1890. About 1908 this building was remodeled and enlarged to meet the needs of the growing congregations. Just following this the church entertained the Wyaconda Association and the building was dedicated to the Lord. Rev. S. M. Brown of Kansas City, preached the sermon.

Ernest is on the **1880 census** with his parents and siblings.

There is an Ernest Chewning on the 1900 census LaGrange, Lewis, MO, listed as a boarder. It says his birth date is 5/1880, that he is 'at school,' and that his parents were born in Iowa. Our Ernest was born in MO, as were his parents. But the entry prior to Ernest's, for LeRoy Lee, has Ernest's information, so it's an error on the census taker's part. Lizzie had died by the time of the 1900 census; Ernest was in school in Lewis County. There was a college there; I would presume this was part of his seminary training.

Ernest's obit says that he began his education in LaGrange College, so this makes sense.

ORDINATION SERVICE.

LA GRANGE, MO.—The First Baptist church of this place called a council of ministers and members of sister churches to assist in ordaining and setting apart Brother E. W. Chewning to the Gospel ministry.

The council, consisting of Rev. C. A. Waters, Canton church; Rev. J. A. Minter, Wyaconda; Rev. A. P. Turner, South Union; Rev. W. T. H. Jones, Gilead; Rev. T. S. Scott, Durham; Rev. A. S. Ingman, of Ten Mile, Rev. J. Sansom of Memphis; Rev. W. R. Painter, LaGrange; Rev. W. O. Shank, Rev. G. A. Crouch, Rev. Tom Campbell, Rev. Jesse E. Chappell, Rev. Ernest Cook, Dr. J. F. Cook and Rev. Cecil Cook, met with lay workers of the different churches at 10:30 a. m., and after organizing, proceeded to the ordination of the candidate. Rev. J. A. Minter was chosen moderator, Rev. A. S. Ingman examiner, Rev. A. P. Turner was asked to preach the ordination sermon and Brother Minter to deliver the charge to the candidate. After the candidate had been thoroughly questioned on Scriptural teaching and Baptist belief, the council adjourned to the lecture room to consider the advisability of recommending Brother Chewning to the church as being qualified to be ordained. Upon examining the ballot it was found that every member voted in favor of recommending the candidate, after which the church listened to a very able and interesting sermon from Rev. A. P. Turner of LaBelle. He found his text in the 4th chapter and 2nd verse of Second Timothy. Following the sermon was the charge by Brother Minter. He said many helpful things to the young man who had entered into the highest calling given to man—preaching Christ to a dying man. The services were closed by a very tender prayer from Rev. C. A. Waters, who asked God's richest blessing upon the Gospel ministry.—Rev. W. O. Shank, Clerk.

NEW PASTOR HERE JANUARY 1.

The Rev. E. W. Chewning, New Pastor of the First Baptist Church of Harrisonville, Will Commence Work Here Next Sunday.

The accompanying photograph is a likeness of the Rev. Ernest William Chewning of Odessa, Lafayette County, Missouri, who will begin work as pastor of the First Baptist Church of Harrisonville next Sunday, January 1, 1922. Concerning the life and past history of the new pastor, the DEMOCRAT is pleased to publish the following data:

The Rev. Mr. Chewning was born on a farm in Clark County, Missouri, January 17, 1879. On New Year's Eve, 1890, he was converted, and united with the Antioch Baptist Church in Clark County, Missouri. His early years were spent on the farm at home, but, when 15 years of age, he began

to work away from home, by the month. He continued in this kind of work, until he entered upon his college career.

lege career.
On December 31, 1902, the Rev. Mr. Chewning was united in marriage with Miss Idella Pearl Stinson of Hancock County, Illinois. Their five children are: Bert S., 18, who is in his senior year in high school; Mary Ruth, 13, in the seventh grade; Ruby Grace, 5; Velma Norine, 3, and Judson Paul, 6 months of age.

In 1909, the Rev. Mr. Chewning was graduated from the La Grange, Lewis County, Missouri, Baptist College, with the degree of Ph. B., and from the Kansas City Baptist Theological Seminary in 1914, with the degree of B. D. He also did a year's post-graduate work in Critical and Exegetical work in Hebrews, before leaving the Seminary.

During his college career, the young preacher was pastor of various country and village churches for part time each. While in the Seminary, he was pastor of the Chelsea Baptist Church in Kansas City, Kans., from October, 1911, to May, 1915. Since the middle of May, 1915, he has been pastor of the First Baptist Church of Odessa, Mo. The Odessa pastorate has been very pleasant, and fairly successful—an average of 40 members a year have been received, and an average of over \$1,500.00 a year has been raised for Missions, Education and Philanthropy.

The Rev. and Mrs. Chewning and children expect to move their family to Harrisonville, just as soon as the weather and road conditions will permit. They will occupy the Baptist parsonage, adjoining the church, West Wall Street.

The First Baptist Church of Harrisonville has been without a pastor, ever since the death of the Rev. Olean L. Brownson, in May, 1921, and its membership will be glad to welcome the new pastor and his estimable family.

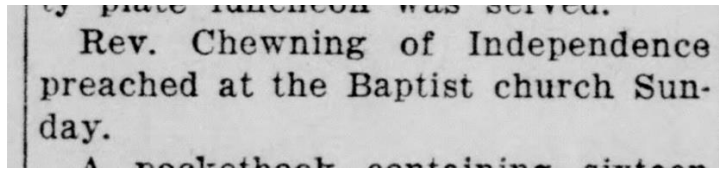

Ernest's obituary says that he was 10 when his father died; 21 when his mother died. He began to work away from home by the time he was 15 until he was 21. It continues that on "New Year's Eve, 1890, Mr. Chewning was converted, later uniting with the Antioch Baptist Church in Clark County."

As I surmised, the obituary says that he "entered La Grange Baptist College and in the spring of 1909 he was graduated with the degree of Ph. B.next course was in the Kansas City Baptist Theological Seminary, from which he graduated in 1914 with the degree of H.D. Later he did a year of post-graduate work in critical and Exegetical Studies in the Hebrews."

Among various churches where he served as pastor, he was at the First Odessa Baptist Church in Harrisonville for more than six years. From there he was pastor at the First Baptist Church in El Dorado Springs, MO. He was a First Master of Masons.

Mrs. Effie (Chewning) Davidson and Mrs. Anna (Chewning) Webster attended the funeral. (Theodore, his brother, had died in 1933.) Apparently Spencer didn't attend.

His obituary mentions that one child died shortly after birth, but that he was survived by his widow, Pearl, Bert S., of Lawrence, KS, Mrs. Charles W. Hight, Jr., of Harrisonville, MO, and Ruby Grace, Mamie Norene and Judson Paul Chewing of the home.

**IN LOVING MEMORY OF REV.
E. W. CHEWNING**

As boys Ernest William Chewning and I grew up near each other, attended the same Sunday school, and at one time were members of the same little country church, Antioch in Wyaconda Association, which has sent forth six of her sons in the last 45 years to preach the Gospel. His father having died when Ernest was ten, the family was left in close financial circumstances, but he and his older brother were able to till the little farm and help the widowed mother rear the rest of the children. By his persistent spirit and strong determination he succeeded in securing a good education, graduating with honor both from La Grange College and the Kansas City Seminary. I will never forget that stormy night in November, 1890, when the revival meeting was in

progress at the little church, Ernest and his brother walked the 2½ miles from their home through the rain, wind and snow to church. The faithful pastor, Rev. J. A. Minter, preached on the 23d Psalm, closing with a heart-stirring appeal for any lost soul to receive the Good Shepherd as his friend. The boy of 11 years stepped boldly out, the tears flowing down his cheeks, and accepted Christ as his personal Saviour. All hearts rejoiced. No one but God knew what the final outcome of that life would be in kingdom work. Ernest was always in his place in Sunday school. In 1896 the Wyaconda Association met at Mt. Salem church. Bro. Chewning and I chanced to be assigned to the same home for the night. I said, "Ernest, let us take a walk." As we strolled out into a big pasture, as we walked along, I told him I believed God was calling him to preach the Gospel, and asked him if he had any impressions that way. He looked me straight in the eyes and said, "Yes, but how did you know it?" I said, "Let us kneel down here and talk it over with the Lord." He poured out his soul in earnest prayer to God, surrendering himself fully to the will of his Master. A while after this as his pastor I took great pleasure in recommending to the church that it license him to preach, which was done. No one who knew Bro. Chewning personally could doubt his great love for the cause of Christ and his one purpose in life to honor Him. With great joy I heard him preach the sermon before the Missouri Baptist General Association at Mexico, Mo., in 1929, on "God's Complete Revelation in Christ" (Heb. 1:1-3). When I congratulated him on the great message he said, "I care not for the praise of men. But do you think I did Him honor?" I have written this brief message about my friend, praying that God will use it to encourage some other boy who may feel the call of God in his soul to give himself fully into the hands of his Master as did Bro. E. W. Chewning.—J. P. Sansom, Canton, Mo.

Correspondence with Charles Ernest Hight, son of Mary Ruth Chewning Hight

3/2013 I wrote to Charles, grandson of Ernest William and Idella Pearl Stinson Chewning, and received this email. I wrote to him again 4/16/2013, sending him a link into my ancestry tree, and saying that I would call him.

Dear Pam:

Thank you for your letter of March 16th and your interest in the Chewning genealogy. I would be interested in learning more about my Grandfather Chewning's family. He died in 1936, two years before I was born, and I have never known that he had siblings or any other information about the generations of the family before him.

Grandfather Chewning was called to Harrisonville in about 1925 to serve as the minister of the First Baptist Church. He had previously been stationed in Odessa, Missouri, and after a number of years in Harrisonville was called to a Baptist Church in Kansas City, Kansas, the name being unknown to me.

Ernest and Pearl had six children, one of whom died in infancy and whose name is unknown to me. The others in descending order were Bert, who was the postmaster at the Kansas University Post Office facility in Lawrence, Kansas. He and his wife, Helen, had no children. My Mother, Mary Ruth Chewning was the next child and I am their only descendant. The next child is Ruby Pipes, widow of Sam Pipes, who is still living in Eldorado Springs, Missouri. She and Sam were dairy farmers North of Butler, Missouri, and they have three children, Marilyn, Jeannette and Larry. I have little contact with any of them. The next child was Mamie who was married and subsequently divorced from her husband, a man by the name of Forbes. They had two children, Maria who lives somewhere in Ohio, and Stephen who lives near Dallas, Oregon. She had two other marriages after Forbes, both of which ended in divorce. She was always my favorite Aunt and was a delightful, sweet person. We had planned to visit her in Oregon but unfortunately she died suddenly a few years ago. The youngest child was Judson Paul Chewning who was lost in the second World War. He was the pilot of a C-47 transport plane which went down in bad weather somewhere between Iceland and Greenland. I last remember seeing him in his Air Force uniform when we had a family gathering at Grandmother Chewning's apartment in Independence, Missouri. He married a strikingly beautiful young lady whose name was Betty soon before he was shipped overseas and they had no children. I believe she remarried sometime after the War, but I have no information about her. Interestingly Grandmother Chewning lived in an apartment house in Independence which backed up to the property owned by President Harry Truman and as a little boy I remember looking out over the fence and knowing that someone important lived in that two story white house.

I am somewhat retired having sold my law practice and building about five years ago. About seven years ago I sold our family abstract and title insurance company which had been in the Hight family since about 1883. My wife, Saragay, and I spend about four months each year at our oceanfront home near Bar Harbor, Maine. Our son, Chandler Fulton Hight, lives in Columbia, Missouri and in 2011 graduated from Westminster College in Fulton, Missouri. He is now slowing working on a Master's Degree and is part of the millions of recent college graduates looking for permanent jobs.

Although I have a certain interest in genealogy my law practice for almost 50 years kept me much too busy to devote time to family history.

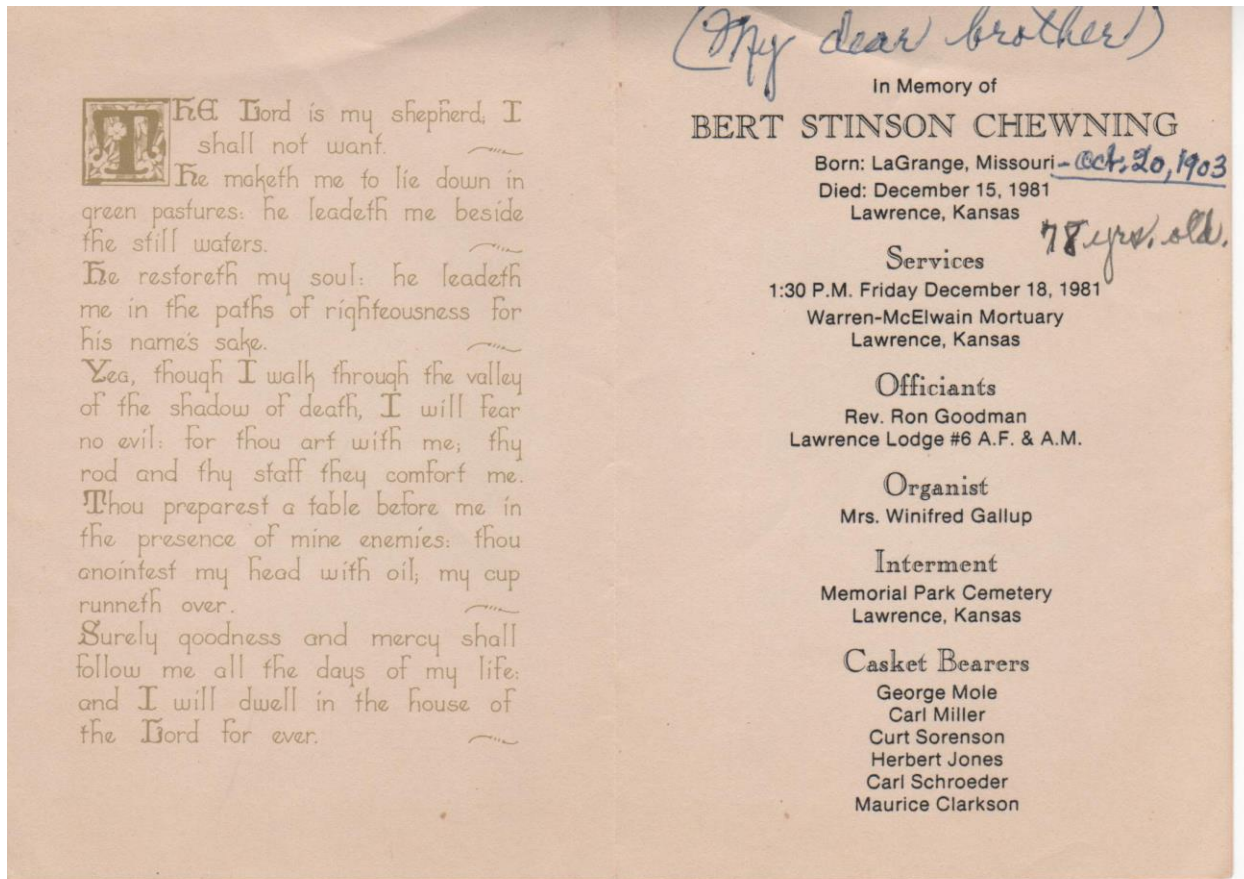

thanks for writing back. i would love to have anything you would like to attach for me. that would be like a goldmine! i did not even know the cannons came from kentucky. and, i had never heard that the beckners were a family line, too. that's funny to me, because in high school i had a good friend whose last name was beckner. we went to school in harrisonville, missouri, so that's not so far removed from clark county, missouri. (i live in arkansas now.)

i know a LOT more about my mother's side of the family than my father's. my dad had no siblings, so i have no cousins or anyone else to get family history from. i was close to my grandmother (his mother) though, so most of what i know came from her. unfortunately, it isn't much though.

here is how i am descended from lizzie:

sarah hight stokes (me) / charles ernest hight (my dad) / mary ruth chewing hight (my grandmother) / ernest william chewing (my gr-grandfather) / elizabeth cannon and moses chewing (our gr-gr-grandparents)

i learned from nita that theodore and ernest were brothers and that theodore was who her husband was descended from. several years ago, she and i happened to be passing through fayetteville, arkansas at the same time and i got to meet her and al, her husband, before he died. they were very sweet people.

i'm sure you have been searching for information beyond granville washington chewing, also. his wife was mary ann hanvey, and her parents were parrick hanvey and mary 'polly' browne, as i'm sure you know, but do you know anything beyond that?

Morning, Sarah. I have a little time this morning to add some more things.

I notice that you said Theodore was Nita's husband; Theodore was her husband's grandfather. Nita's husband and my father were first cousins.

Let's see - I'll go farther back into the Cannons.....

I decided when I started doing this genealogy last year was that I would trace my grandparents (and gr, grgr, etc.) as far as I could. Then I would trace their children, but not THEIR children. In other words, I wouldn't trace the cousins of my grandparents. I found that when people moved to another part of the country, they often went with their sisters and brothers. So I have the 'story' of my grandparents, then the 'story' of their children. I've researched Ernest Chewing, as best as I could, but didn't do his children. I would love to have what you have on them, though. My dad was raised hearing stories of these people, so he loves whatever we find.

You asked about getting an ancestry membership. I couldn't work without it. My neighbor and I split the price of an annual membership, so it's not too bad. I have decided, at least at this point, to stop my research when the ancestor hits American soil, so I don't need the international version yet. Maybe if I get enough done on the people in front of me, I'll push back in time.

There is a lot of information online concerning the Beckners, including a book, but I think it's out of print. I look for it occasionally on ebay but no luck.

I store my documents using Word 2007. Because you have a new laptop, I'm guessing you have that version. If you can't read what I'm sending, then I can store in a compatible version.

If this would be easier for you, you could send me a memory stick, or I could get you one and you could reimburse me, and I could put all the Chewing, Cannon and Beckner information on it for you.

hi pam,

i wanted to get back with you and tell you i have really enjoyed reading everything you sent me. i have "open office" on my laptop, which is the free software that opens most word documents, but not the word 2007 versions. my husband works two hours away during the week, but i figured that when he got home this weekend, he would be able to find a way to open the documents, and he did. (he is much better at the computer than i am.) he downloaded a compatibility program that would open them. i didn't want you to have to go to any extra trouble since you had already been so nice to send me the information.

i started doing a family tree through ancestry.com, and when i get all the names and dates entered that i have, i think i will buy a subscription so i can do some real research. it's pretty cool how those little leaves pop up in the corners of the name boxes when ancestry finds some additional information, and i want to be able to see what's been found!

the information that you have on ernest chewing is about all i have, too. you had written in the narratives that he and pearl had a child who had died in infancy, and i didn't know that. my grandmother had only talked about the five children who had lived to adulthood, including occasionally mentioning her brother, paul (judson). i do remember her saying that during WW II, he was not allowed to say where he was, and it was upsetting to her mother. he sent the family a letter with some hints, such as 'the land is green' and things of that nature, and they were able to discern that he was in greenland. then, sure enough, when his plane went down and he was presumed dead, they were told it had gone down between greenland and iceland. his body was never found, and his grave at the orient cemetery in harrisonville, mo is empty. my grandmother, mary ruth chewing hight, has been dead a couple of years, and her sister, mamie, died a year or so ago. bert has been dead awhile, and ruby is still alive. we send christmas cards to each other, but i haven't seen her in years. when my grandmother and mamie were both still living, mamie would come to harrisonville every fall to see my grandmother. the last time this was to have happened, mamie had her plane ticket bought, then became ill and couldn't come. my grandmother was quite sad about this, as she was in a nursing home by this time, and she told me that she knew she would never see her sister again. mamie ended up moving to oregon where her son lives so he could take care of her until she died. they never did get to see each other again. you were correct about the seminary in la grange. la grange is where my grandmother was born. i never knew ernest, but i do remember going to pearl's

house when i was little. she died when i was about 10. ernest pastored the baptist church in harrisonville for a number of years. when i was young, there was a very old lady in the church my mother, sisters, and i attended (not the one ernest had pastored). one day she came up to me and told me that my great-grandfather ernest chewing had baptised her in the lake when she was a little girl. that lady is no longer living. i remember being surprised that she knew who my relatives were.

as i told you, i don't have a lot of information on this side of my family. my dad divorced my mom when my sisters and i were between 6 months and 6 years old. he quickly remarried and ended up adopting a son and severing his ties with us. we maintained a good relationship with our grandmother, but it wasn't often that we could get her into a story-telling mode. i know my dad has 4 family bibles, at least 1 of which is a chewing bible. there were pictures in it, but i have no idea who the people are. when my grandmother died, he let me keep the bible for a couple of hours, and i ran to wal-mart and made copies of the pictures just in case i could ever figure it out. so far, no luck though.

if i send you a memory stick, about how many gigs do you think it will need to be? i think that's a good idea, if you don't mind doing that. you are welcome to anything i have, though i'm sure you probably already have what i have!

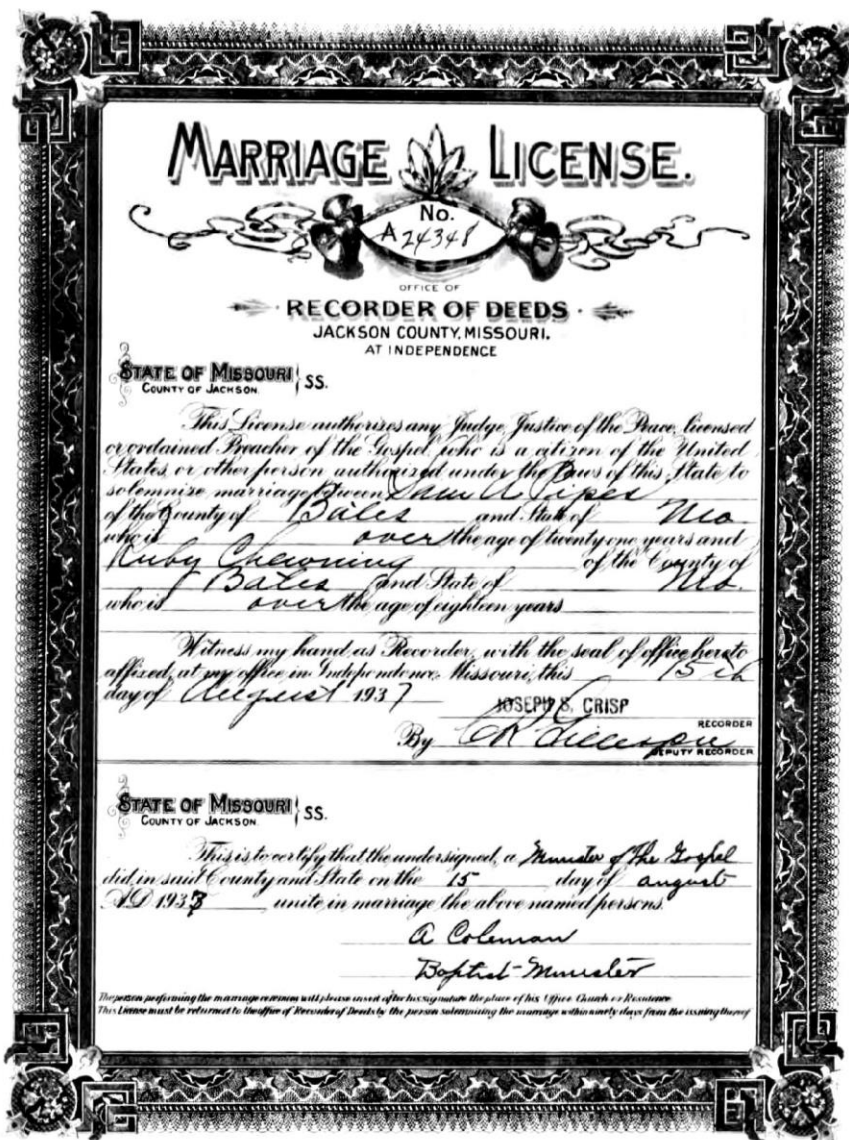

She was the third born of Ernest William Chewning and Idella Pearl (Stinson) Chewning on July 21, 1916, at Odessa, MO, where he was pastor of the Odessa Baptist Church. Three other siblings were born, with one dying at

childbirth, and all preceded her in death. Bert, Ruth, Ruby, Mamie and Paul were all soldiers for Christ and His sacrifice.

In childhood and as a young adult she endured WWI, the Great Depression, and as a church family they moved from Odessa to Independence to Harrisonville to El Dorado Springs, where in 1936, she met Samuel Allfree Pipes. **They were married on August 15, 1937 and bought the three generation Stinson farm northwest of Butler, MO, in Bates County from her mother.**

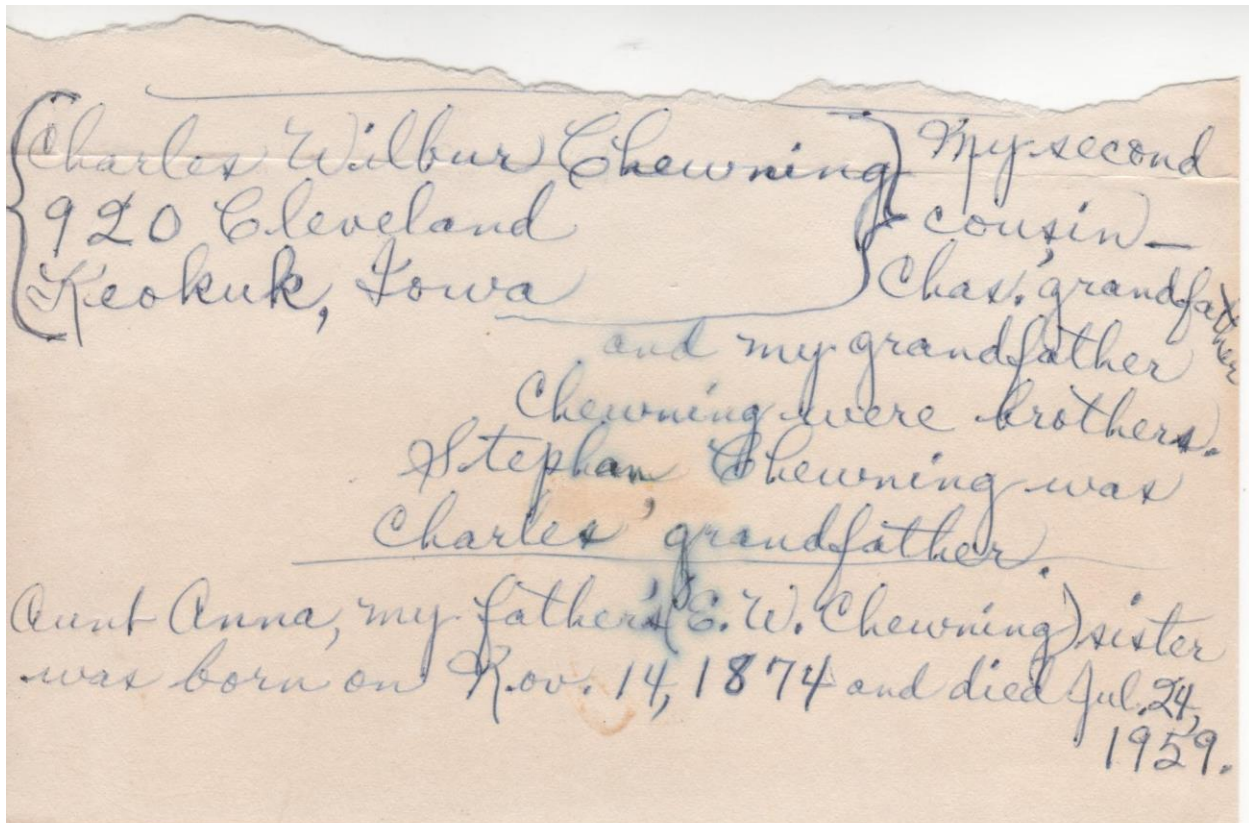

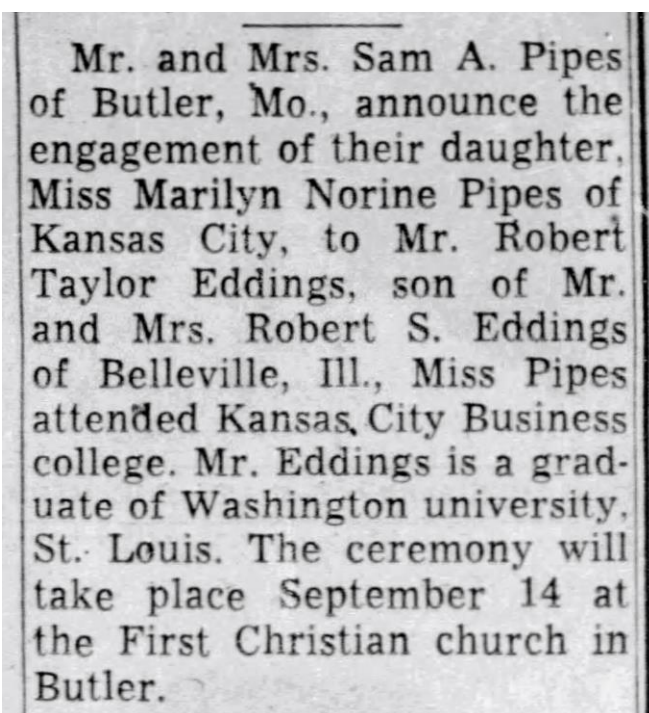

SECTION 451.040—LICENSE REQUIRED.—1. Previous to any marriage in this state, a license for that purpose shall be obtained from the officer authorized to issue

 person authorized by law to solemnize marriages.

2. Before applicants for a marriage license shall receive a license, and before the Recorder of Deeds shall be authorized to issue a license, the parties to the marriage

The weather here is so dry — we wish it would rain soon. The corn crop would be a fine one if it only had moisture right away.

Aunt Lillie and Uncle Lefe (Mother's sister) and her husband, you know) have been visiting with us for the past week. They left this morning, returning to their home in Des Moines, Iowa. She had such a nice visit together.

Tell Aunt Effie and all "hello" for me. Mother sends her love and best wishes to all.

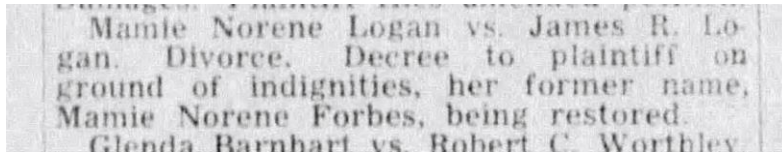

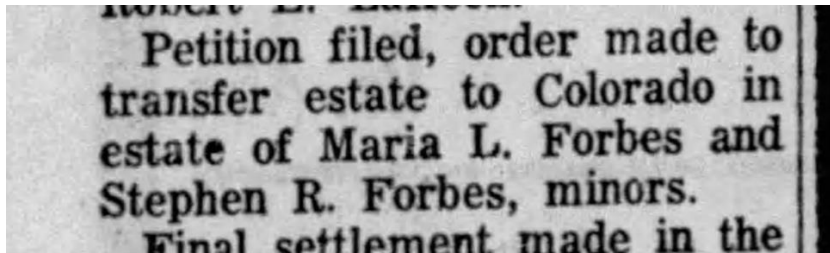

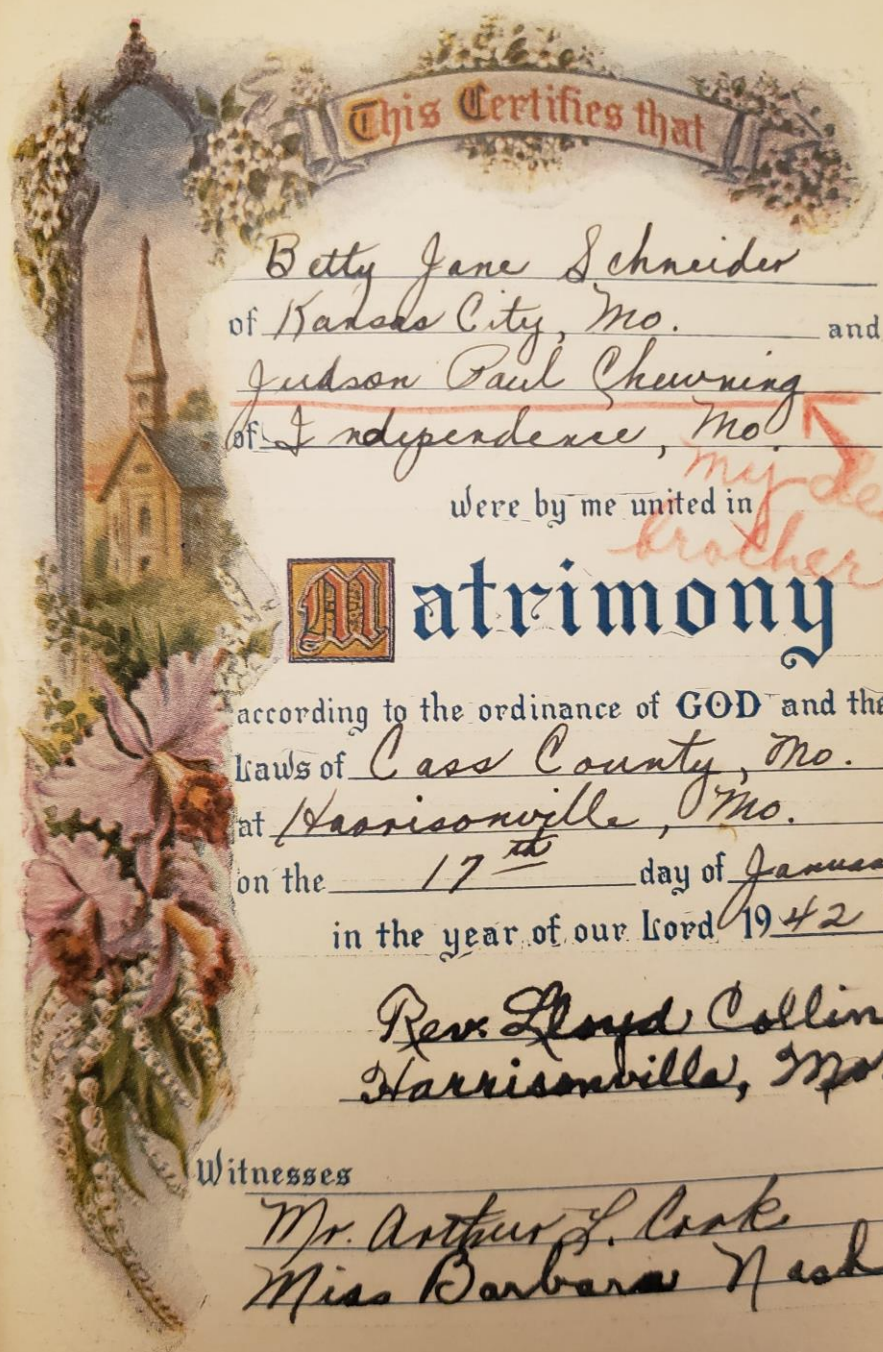

Tells More About Accident.—
Mrs. Betty Jane Chewning of Kansas City recently was visited by Lt. Roy Aldermott, who told Mrs. Chewning more about the plane mishap August 30, 1944, which took the life of her husband, Second Lt. Judson Paul Chewning, a pilot of a C-47 army transport. Lieutenant Aldermott, pilot of another C-47, stated the planes took off from Greenland in such severe weather the airmen could not see their own wing tips, but the supplies the planes were carrying were needed so urgently by American forces in Europe that the trip was vital. Many of the planes experienced engine trouble, but all reached Iceland en route except that piloted by Lieutenant Chewning. It is not known when he was forced down in the Greenland-Iceland area, but the airmen had been told the cold was so intense they would be able to live only one and a half hours at most if forced down.
Lieutenant Chewning, 23, was a son of the Rev. and Mrs. Ernest W. Chewning, the father dying in 1936 at Eldorado Springs, Mo. He formerly was pastor of the Harrisonville Baptist Church. Paul entered military service July 13, 1942, and was commissioned a second lieutenant in the Army Air Corps in January, 1944. The youngest in a family of six children, a sister, Mrs. Charles W. (Ruth) Hight, lives in Harrisonville.

DEATH OF LT. PAUL CHEWNING

The final chapter in the news concerning the death of Lt. Paul Chewning, a former Butler boy, has been brought to members of his family by Lt. Roy Aldermott of Kansas City. Lt. Aldermott returned just recently to the States from Germany where he had been a prisoner of war of the Germans after having been shot down in September, 1944.

The death of Lt. Chewning was reported as of August, 1944. According to the story told by Lt. Aldermott, Paul was aboard a C-47, flying supplies from the United States to Europe. Fourteen cargo ships made up the flight which left the United States August 20. The flight had been grounded in Greenland a week because of bad weather. A message, telling of the urgent need for them to push through, sent the flight on its way in weather so foggy and cold that the pilots could not see the wing tips of their own planes, according to Lt. Aldermott. Lt. Chewning's plane was the only one which failed to reach Iceland. Weather conditions prevented a search for the missing plane.

Lt. Chewning attended Butler high school. He began his training in July, 1942, and received his pilot's wings at San Antonio, Tex., in January, 1944.

He is survived by his wife, Mrs. Betty Chewning of Kansas City, his mother, Mrs. E. W. Chewning of Independence and three sisters, Mrs. Robert Forbes of Independence, Mrs. Sam Pipes of Butler, and Mrs. Charles Light of Harrisonville, and one brother, Bert Chewning of Lawrence, Kans.
